- Order specialist medical examinations and continue treatment based on the results of the examinations. and continue to make changes to the treatment based on the outcome of the treatment.
- Provide the patient with the necessary psychological and rehabilitation treatment and provide the patient with information on preventive measures.
- Performing operations on patients requiring treatment of common diseases and specialist health care.
- Write and record patient health information and share it with those who need to share it.
- Provide information to various parties in order to fulfill legal and technical duties and assist and cooperate in research and investigations conducted in the field of work.

- Prepare legally required medical reports, participate in medical investigations and give expert opinions where required.
- Participate in the planning and implementation of public awareness programs to prevent diseases requiring specialist health care.
